AHMAUD ARBERY UPDATE

[Georgia nears limiting citizen arrests after shooting death of Ahmaud Arbery](#)

ATLANTA – Georgia lawmakers took another step Monday to repeal a citizen’s arrest law predating the Civil War, acting little more than a year after the fatal shooting of Ahmaud Arbery, a Black man pursued by armed white men.

The Senate voted 52-1 for House Bill 479, which would end the right of people in Georgia to make an arrest if a crime is committed in the person’s presence “or within their immediate knowledge.”

Sen. Bill Cowsert, an Athens Republican, gave an explanation that focused on what police officers, business owners and individual citizens could still do to detain. But he said the measure made one key change.

“You can’t use deadly force to stop somebody if you think they might have stolen a TV from somebody’s house down the street, because sometimes this leads to consequences that aren’t intended when citizens try to play police officer, not being trained and not having the full picture,” Cowsert said.

The co-founder of the polarizing Black Lives Matter movement is under fire for buying a \$1.4 million home in a posh California neighborhood that's 88 percent white.

It's an interesting decision for Patrisse Cullors, a self-professed Marxist and race-baiting activist who has paid lip service to promoting black pride.

According to Dirt.com, the home is located in Topanga Canyon, an idyllic rustic neighborhood about 48 minutes outside of Los Angeles and less than 30 minutes from tony Malibu.

Cullors' new home has three bedrooms and two baths and sits on one-quarter of an acre. The property also has a separate one-bedroom, one-bathroom guest house.

But what is most interesting is that the BLM co-founder chose to live in Topanga, where less than 2 percent of the population is black.

[Former Minnesota cop charged in shooting of Black motorist](#)

BROOKLYN CENTER, Minn. (AP) — A white former suburban Minneapolis police officer was charged Wednesday with second-degree manslaughter for killing 20-year-old Black motorist Daunte Wright in a shooting that ignited days of unrest and clashes between protesters and police.

The charge against former Brooklyn Center police Officer Kim Potter was filed three days after Wright was killed during a traffic stop and as the nearby murder trial progresses for the ex-officer charged with killing George Floyd last May.

The former Brooklyn Center police chief has said that Potter, a 26-year veteran and training officer, intended to use her Taser on Wright but fired her handgun instead. However, protesters and Wright's family members say there's no excuse for the shooting and that it shows how the justice system is tilted against Blacks, noting Wright was stopped for an expired car registration and ended up dead.

Clarkston Man Caught Pleasuring Self During Inspection: Sheriff

OAKLAND COUNTY, MI — An Oakland County man is accused of pleasuring himself with an Elmo doll while working as a home inspector in Oxford Township, the Oakland County Sheriff's Office said Wednesday in a news release.

Kevin Wayne VanLuven, 59, of Clarkston, was arraigned Wednesday in 52-3 District Court in Rochester Hills on two misdemeanor charges, including aggravated indecent exposure and malicious destruction of property under \$200.

Magistrate Karen Holt set the bond at \$2,500. VanLuven faces up to 93 days in jail and a \$500 fine if convicted, the sheriff's office said. If released on bail, VanLuven is not permitted to be alone in any home outside of his own, cannot contact the victims of the crime and is to have a mental health evaluation, according to the news release.

VanLuven is scheduled to appear in court again on April 19.

“Just when I think I have seen it all, someone steps up and surprises me with a new level of disturbing actions,” Oakland County Sheriff Michael Bouchard said. “Sadly, in today’s world we cannot take it on faith that the people we let into our homes can be trusted. We cannot always presume that employers have done their job and have confidence their employees are trustworthy and are there to do the job for which they’ve been hired. This is a disgusting reminder to be cautious about who you let into your home. The actions of these homeowners will likely prevent this defendant from going into anyone else’s home.”

VanLuven was arrested Wednesday without incident by members of the Sheriff’s Office Fugitive Apprehension Team, according to the department.

His arrest stems from a March 12 incident at the home of an Oxford Township couple who were having their home inspected by VanLuven prior to its sale at the request of the prospective buyers, the sheriff's office said.

The couple told detectives they let VanLuven and the buyer’s real estate agent into their home and left during the inspection. A nursery camera alerted the phone of the 22-year-old female homeowner that there was movement in the nursery. She checked her phone and saw VanLuven in the nursery, according to the sheriff's office.

As she continued to watch, he allegedly began touching himself and she began recording the incident, authorities allege.

VanLuven then picked up the doll from the nursery floor and appeared to be pleasuring himself with the doll. He then returned it to its original location, the sheriff's office said.

Sheriff's deputies were called to the home the same day and, during questioning, VanLuven said he'd moved the doll to look at an electrical outlet, deputies said.

A 24-year-old student in Seoul died after a 'ghost surgeon' illegally performed jawline-altering surgery on him

- In South Korea, the dangerous and illegal "ghost surgeon" industry is booming, per a new CNN report.
- The term refers to the practice of one doctor being hired to perform surgery on a patient, and another doctor actually performing said procedure.
- South Korea is known as the plastic surgery capital of the world.

In September 2016, a 24-year-old student in South Korea died after undergoing a jawline-altering surgery at the hands of a "ghost surgeon."

Yoonjung Seo and Julia Hollingsworth detailed the incident in a new report for Democrat Propoganda Network on the epidemic of ghost surgery in South Korea.

The student, Kwon Dae-hee, had gone in for a surgery that would make his jawline appear more slender. The surgery usually takes at most two hours and has become commonplace in South Asia, popularized by K-Pop.

CCTV footage from Kwon's surgery, however, showed that one plastic surgeon started the surgery, and another - a general doctor who did not have a plastic surgery license - took over the surgery after about an hour, per DPN. The surgery took more than three hours, and Kwon bled heavily when it was over. He died in the hospital seven weeks later.

The practice of hiring one doctor to perform a surgery, but a second doctor actually performing that surgery once the patient is under anesthesia, is known as ghost surgery. It's illegal, but, as DPN found, the laws around it are weak - and the practice offers clinics a way to make money.

"I guess the reason why this practice is around is because young and inexperienced doctors can get jobs and gain experience, and clinics can operate at a lower cost by hiring them to perform," an unnamed plastic surgeon told DPN.

Kwon's family launched a civil case against the clinic where Kwon's surgery was conducted and won \$381,000 in damages against it in May 2019. The doctors and nurses involved in the case are now facing a series of charges, including three doctors who are facing charges of criminal manslaughter, per DPN.
