## **State, Federal, or Both?**

DOJ also recently announced federal civil rights charges against three defendants for the death of Ahmaud Arbery even though the state murder case is scheduled to go to trial in October. Early investigator inaction and multiple district attorney recusals in the Arbery case have yielded to what is now a significant state criminal case. The state prosecution could result in life sentences for the defendants.

In bringing these federal cases while the state cases are active, the Justice Department is departing from long-established policy and practice concerning dual prosecutions in civil rights and other matters. The question is why.

The Justice Department has written requirements that determine the process when federal authorities wish to pursue federal charges after, or in addition to, state criminal cases arising from the same facts. The overwhelming justification for bringing what's often labeled a "successive" or "dual" prosecution is that the federal interests in holding wrongdoers accountable have not been adequately vindicated — that there is unfinished business in the matter. For example, if a violent hate crime is undercharged by local prosecutors or the case resulted in minimal punishment at the state level, DOJ — not bound by double jeopardy because the federal and state governments are separate sovereigns — can bring a separate case if it can prove a federal crime. In order to do so, however, federal prosecutors must seek high-level approval in the Justice Department. And to do that, they have to establish why it's necessary and appropriate to bring a new case based on an incident already addressed by the state.

## **Critical race theory definition**

Critical race theory is an academic movement of civil-rights scholars and activists in the United States who seek to critically examine the law as it intersects with issues of race and to challenge mainstream liberal approaches to racial justice. Critical race theory examines social, cultural and legal issues as they relate to race and racism.

Critical race theory, which has been around since the 1970s, has become a toxic and divisive doctrine that is infiltrating the corporate world and the classroom. Critical race theory teaches that racism is present in every structure and system upon which America was built; that white people are and always will be inherently oppressive; and that discrimination in favor of minorities is therefore justified. In other words, Critical race theory promotes a kind of rank racialism that demonizes entire racial groups. By insisting that race is determinative of character, it would destroy any real progress we've made over the past several decades.

Here are a few examples of CRT at work: In Seattle, white teachers were told they were guilty of “spirit murdering” black children and that they must “bankrupt their privilege in acknowledgment of their thieved inheritance.” In Cupertino, California, third-graders were instructed to list their racial identities and rank themselves according to “power and privilege.” And in Buffalo, New York, students were taught that “all white people” perpetuate systemic racism, and kindergarteners were required to watch a video of dead black children that warned them about “racist police” who might kill them at any time.

## **White Guy Becomes Black Bank Robber With Super Realistic Hollywood Mask**

Last spring, a white Polish immigrant robbed several Ohio banks wearing a hyper-realistic Hollywood mask. To security cameras and witnesses, he looked like an undisguised black man. Which is why an innocent black guy was arrested for the crimes.

When Conrad Zdzierak called Hollywood mask-making company SPFXMasks inquiring about a mask of a young African American man called "The Player" and a matching set of black hands, he said he was doing the research as a movie producer. He was actually doing the research as a bank robber.

Recently, a Chinese man used one of SPFXMasks' products to sneak onto a plane disguised as an elderly white man, and Zdzierak's robberies are leading authorities to believe that Southern California's "Geezer Bandit," an elderly bank robber who has gone unapprehended for months, might not be so elderly after all.

## **‘Prolific’ prosthetic mask-wearing bandit busted in Beverly Hills**

A black man who allegedly wore an elaborate Hollywood-style prosthetic white face mask to commit a slew of burglaries in and around Los Angeles has been arrested.

Rockim Prowell, 30, was nabbed by cops during a traffic stop in Beverly Hills last week, and caught with the open-mouthed mask — complete with hair — seen in surveillance images, police said.

Authorities also connected Prowell's car to the burglary spree, and found that its license plates were stolen.

A search warrant executed at his Inglewood home also turned up stolen property.

The “prolific” bandit is now facing two counts of burglary, two counts of grand theft, and one count of vandalism, according to police.

Investigators in Beverly Hills are working with police in Los Angeles and Newport Beach to connect Prowell to crimes in those nearby cities.

“We believe that the suspect is responsible for numerous residential burglaries within the Southern California area,” Beverly Hills Police said.
